To Whom It May Concern

The Supplier declares that it has read and understood the EU Directive 2015/863, RoHS 3, on restriction of the use of certain hazardous substances in Electrical and Electronic equipment, below referred as the "RoHS directive". The RoHS Directive prohibits the use of certain substances (including deca BDE) in Electrical and Electronic Equipment, below referred as the "RoHS requirements". This new directive adds 4 Phthalates onto to the original ten hazardous substances, shown below. In accordance with current RoHS, RoHS2, RoHS 3 (Restriction of the use of Hazardous Substances) and WEEE (Waste in Electrical and Electronic Equipment) legislation enacted by the EU and adopted by many other countries, the products listed below contain no more than the allowed amounts (either less than 100 or 1000 ppm depending on substance) of the following hazardous substances.

Cadmium (Cd): 0.01%
Mercury: 0.1%
Lead (Pb): 0.1%
Hexavalent chromium (Cr6+): 0.1%
Polybrominated biphenyls (PBB): 0.1%
Polybrominated diphenyl ethers (PBDE): 0.1%
Bis(2 -Et hylhexyl) phthalate (DEHP): 0.1% (added in 2015);
Benzyl butyl phthalate (BBP): 0.1% (added in 2015)
Dibutyl phthalate (DBP): 0.1% (added in 2015)
Diisobutyl phthalate (DIBP): 0.1% (added in 2015)
Bis(2-Ethylhexyl) phthalate (DEHP): max 0.1%
Benzyl butyl phthalate (BBP): max 0.1%
Dibutyl phthalate (DBP): max 0.1%
Diisobutyl phthalate (DIBP): max 0.1%


After evaluation of the RoHS requirements, Armacell hereby certifies that the following products fulfill the RoHS requirements:
